Nomination and Election Information Process Vegetables NZ - Board Representatives

Process Vegetables NZ Board representatives are elected by growers, this is your opportunity to have direct input into the election process.

Any grower who has paid a levy to Process Vegetables New Zealand during the past 12 months from 1 April 2021 is eligible to nominate, second a nomination or be nominated for the position of Process Vegetables NZ Board Representatives.

Positions for Nomination - Process Vegetables NZ Board Representatives

There is an annual retirement by rotation (every 3 years) for Board representatives. Board representatives who are retiring by rotation and are available for re-election **do not** need to be nominated.

Board representatives available for election, are deemed to be nominated and will be elected or re-elected if there is no opposing candidate.

- **Hugh Ritchie (Hawkes Bay)** - retires by rotation, *is available for re-election*, is deemed to be nominated and will be re-elected if there is no opposing candidate.
 - **Jim Sim (Canterbury)** - retires by rotation, *and is not available for re-election*.

All nominations must be seconded.

Nominations must also be signed by the nominee to confirm they are willing to stand.

When do nominations open and close?

Nominations open on **Thursday 16th June** and close at **5:00pm on Thursday 7th July 2022**.

Where do I send my nominations?

Nomination forms should be returned to Process Vegetables NZ by emailing to Lynda.banks@hortnz.co.nz.

Will there be a vote?

If there are more nominations than positions available, levy paying growers of Process Vegetables NZ will be eligible to vote in an electronic vote.
